#### 2.2 - Catering to Student Diversity

2.2.1 - The institution assesses the learning levels of the students and organizes special Programmes for advanced learners and slow learners

The College has a Student Information System (MIS) and also having ISO certification-2015, used for maintaining the data of all the enrolled students and to satisfy its stakeholders. The access to the student's data given to the subject teacher, class teacher, Head of the Department, Principal, student, this helps them to track the student progress. Subject teachers, class teacher and mentors along with Head of the Department, identify the slow learners & advanced learners by tracking their academic performance in the Internal tests conducted as per the calendar of events. Slow learners: The Internal Assessment marks and attendance of the slow learners are informed to their parents over the phone call or in personal meet. The tutorial and remedial classes are conducted to improve their academic performance. A faculty counsellor is assigned to each student to monitor the overall progress. Online Material is made available to students all the time. Visual charts in Laboratories also help slow learners to get clear idea about the topic. Advanced learners: Advanced learners are constantly guided and encouraged for participation in various competitions. The mentors identify their interest and talent in various domain and then guide & motivate them. Students are encouraged to participate in National and International Level events like AVISHKAR - Research Competition, paper presentation, poster presentation, Quiz competitions, online webinars, etc. Students are given the opportunity to utilize the laboratories during the free hours to learn other experiments beyond the curriculum.
