Subject: About the admission of First Year B.Sc. (Computer Science) course.


Respected Sir/Madam,



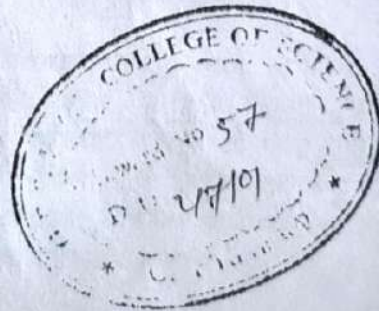


